The above-mentioned parties to this Memorandum of Understanding do hereby agree to develop collaborative activities of mutual interest on the following terms and conditions.

1. Faculty Exchange Programme between the above-mentioned departments of two colleges will be initiated for Honours Courses only.
2. Faculty from New Alipore College will visit Gokhale Memorial Girls' College thrice a month, while faculty from Gokhale Memorial Girls' College will visit New Alipore College twice a month.
3. The above-mentioned departments of two colleges will decide on class allotment and load distribution through mutual consent.
4. The visiting teacher on Faculty Exchange Programme will take responsibility only for the portion of syllabus allotted to him/her by the Head of the Department of the recipient college.

6. A separate roster will be maintained by each college to be duly signed by the visiting teacher on Faculty Exchange Programme.
7. Each college will provide a monthly statement of the services rendered by the visiting teacher on Faculty Exchange Programme.
8. It shall be mandatory for each participating college to ensure that all the departmental classes be held according to the set time-table without disruption.
9. The above-mentioned departments of two colleges will organize joint seminars, symposia and the like with collaboration and participation of all the faculty and the students of both of them.
10. Faculty members of Economics of both the colleges will use the libraries of both the colleges for academic pursuit.
11. This Memorandum of Understanding shall remain in force for a period of ONE year commencing from the date of signing it.
12. This Memorandum of Understanding may be extended following review after one year through written agreement signed by the concerned authorities of the two colleges.
13. Any part of this Memorandum of Understanding may be revised, supplemented or deleted through mutual consent of the concerned authorities of the two colleges.

The signatories to this Memorandum of Understanding welcome its introduction in a spirit of cooperation and do, without prejudice, agree to the terms and conditions mentioned hereinabove.
