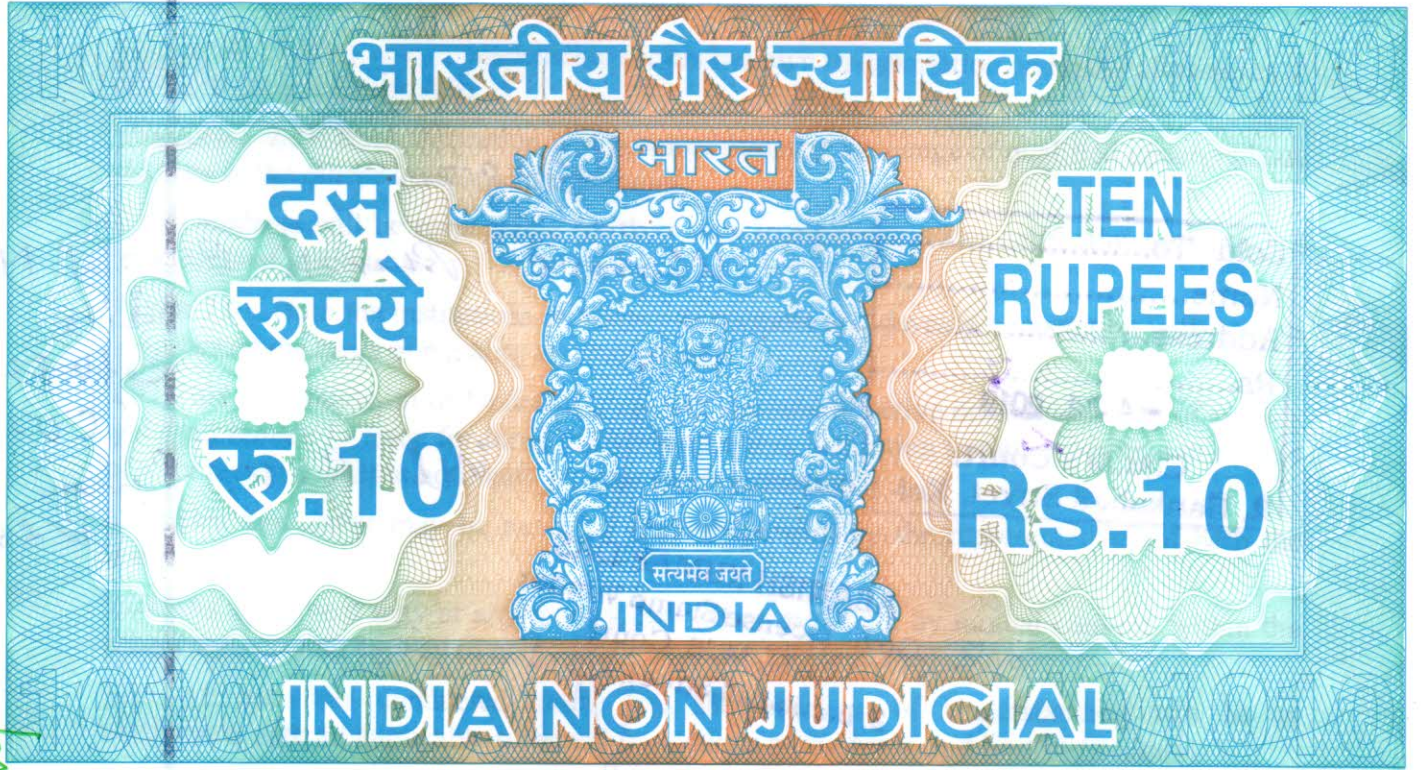

1.02: Each Teacher will be responsible for his/her own transportation and daily allowances to and from the host institution.

Students: 2.01: Each institution will promote semester exchange of qualified undergraduate students in the other's academic programmes.

2.02: Students will be responsible for their own transportation and daily allowances to and from the host institution.

Term: 3.01. Both the institutions undertake to promote and develop cooperation with various activities on the basis of equality and reciprocity.

3.02 This Memorandum of Understanding will become effective on the final date of signing and shall remain in force for three years unless either institution terminates it by a minimum of a six month's written notification to the other institution.

3.03 This agreement may be extended after discussion by the representatives of both the institutions.



3.04 The agreement may at any time be revised or modified, by mutual consent, within the period agreed upon by way of clause 3.02 **and/or** 3.03 mentioned above.

3.05 All activities conducted under this Memorandum of Understanding will be in accordance with all applicable rules and regulations of the home and host institutions.

3.06 Both the Institutions hereby jointly agree that the *Original copy* of the instant Agreement shall remain in the custody of "**KISHORE BHARATI BHAGINI NIVEDITA COLLEGE (CO-ED)**" and a *Duplicate Copy* of this Agreement, which will be signed in Original and executed on the same day and at the same time with the *Original copy* by both the Institutions shall remain in the custody of "**NEW ALIPORE COLLEGE**" and the said *Duplicate Copy* of Agreement will be treated and considered as good as *Original* and also will bear the same legal value as the said *Original copy* of Agreement.


