The MoU is valid for a period of 5 years from the date of signing by the authorised signatories of each party.

Other Conditions:

- This linkage will respect Intellectual Property Rights and any other intellectual matter developed by the collaborative efforts of the two colleges. Both the colleges shall respect and retain confidentiality in each any of the collaborative efforts and all collaborative academic exercises shall be guided, directed and impelled by the greater academic interest of both the colleges, and not any other/ commercial interest.
- The institutions agree that there is no intention to share any confidential or proprietary information in any collaboration under this MoU.
- No legal relationship between the two colleges is implied through this linkage, any of the two colleges can choose to terminate the linkage with a prior notice of six months.
- Both the institutions understand that all financial arrangements will have to be negotiated and will depend on the availability of funds.
- The academic linkage shall uphold the ethos of holistic and integrated academic excellence and growth followed by all higher education institutions of the country, and shall not in any way impede or affect the individuality of each other in any way.
