

NOW THIS MEMORANDUM OF UNDERSTANDING WITHESSETH and it is agreed by and between both the colleges hereto as follows:

- 1. SCM & NAC have necessary of the concerned Governing Bodies regarding the Memorandum of understanding.
- 2. That for the purpose mentioned ut supra both the colleges have agreed to exchange in the fields like Academic Exchange (including the joint classes held for the students of both the colleges, by the faculties of different department) in a week/fortnight, modus operandi of which will be settled jointly by the concerned department of both the colleges.

A well concerned contribution of the academic journals of both the colleges, publishing of students' Magazines/ webzines, departmental ejournals etc.
- 6. Library facilities: Resources of both the colleges can be shared, modus, operandi of which will be settled jointly by the Library departments of the colleges.
- 7. It is agreed by both the colleges that expenses to be incurred in connection with different programmes will be borne by the respective colleges of the participants/ candidates.
- 8. Both the colleges have agreed that if additional assistance is required in that event Principal of both colleges will settle mutually after discussions.
- 9. That in respect of the abovementioned programmes and/or activities only Principal of both the colleges will take all responsibilities regarding selection of candidate(s)/participant(s) and other matters of the said purpose.
- 10. If any disputes arise in respect of this MOU in that case Principal of both colleges will discuss and settle the matter amicably.
- 11. Both the colleges have entered into this Memorandum of understanding for the period of five years in second phase.
